The Florida Department of Transportation (FDOT) welcomes you to the Public Hearing for the proposed improvements to I-295 Collins/Blanding at Collins Road Interchange project in Duval County, Florida.

Project Purpose: The purpose of this project is to reduce traffic congestion at and around the nearby intersections of Collins Road and the I-295 Collector Distributor by widening ramps, extending turn lanes, and making interchange improvements. This project will improve the flow of traffic along Collins Road at the I-295 Collector Distributor and surrounding intersection, while taking into account the increase in traffic from the recent development in the area.

Proposed Project: The proposed project will construct a jug-handle intersection at the Collins Road and I-295 Collector Distributor northbound on and off ramps, which will remove the eastbound left turn lane from the existing on and off ramps, to a new proposed signal east of the existing signal. In addition, a westbound through lane will be constructed starting west of the northbound on and off ramps and ending as a second left turn lane at the Collins Road and Rampart Road intersection. The I-295 Collector distributor southbound off-ramp at Collins Road will also be widened to include two left turn lanes, two through lanes, and three signalized right turn lanes. This proposed project includes pond modifications, additional right-of way and access management changes.
