The Florida Department of Transportation (FDOT), welcomes you to the public meeting to discuss proposed improvements to the Hart/Talleyrand Expressway.

The City of Jacksonville has proposed to make modifications to the Hart Bridge ramps to Liberty Street. As part of the project, FDOT is conducting a Project Development & Environment (PD&E) Study to evaluate the existing configuration that connects Liberty Street to the Hart Bridge with elevated ramps. The project proposes to demolish the ramp from west of A. Phillip Randolph Boulevard to east of Festival Park Boulevard Avenue, construct an eastern ramp from the Hart Bridge to street level on Bay Street, and construct a western ramps east of A. Phillip Randolph Boulevard. This new configuration will divert traffic from the elevated expressway to street level providing direct access to the Sports and Entertainment Complex, the Talleyrand port area and Metropolitan Park.

The following proposed road transfers to the City of Jacksonville are also included as part of this project.

- Ramps and Hart Bridge Expressway from east of Liberty Street to Festival Park Avenue
- Adams Street from Main Street to Liberty Street
- Monroe Street from Main Street to east of Washington Street



The environmental review, consultation, and other actions required by applicable federal environmental laws for this project are being, or have been, carried out by the FDOT pursuant to 23 U.S.C.§ 327 and a Memorandum of Understanding dated March 14, 2016 and executed by the Federal Highway Administration and FDOT.
