# Proposed Modifications

The Jacksonville Transportation Authority (JTA) is currently considering improvements to Alta Drive between I-295 and Burkit Lane, including:

- ▣ Widening the existing roadway to a six-lane, divided roadway from I-295 to Faye Road
- ▣ Widening the existing roadway a four-lane urban roadway to Ashgrove Road
- ▣ Widening the existing roadway to a five-lane roadway to Burkit Lane

# Proposed Modifications

- ▣ Constructing bike lanes, sidewalks and a closed drainage system
- ▣ Upgrading signals at Faye Road
- ▣ Re-striping the bridge over Dunn Creek
- ▣ Adding lighting
- ▣ Installing new signals at Misty Marsh Drive and Port Jacksonville Parkway
- ▣ Reconstructing the CSX railroad crossing

# Proposed Modifications

Within state right of way on Alta Drive, FDOT requests that JTA make the following changes to reduce conflicts and enhance safety:

- ▣ Widen the median south of Faye Road
- ▣ Construct a directional median opening
- ▣ Restrict the eastbound approach of Faye Road to right turns only
