### **Project Overview**


The First Coast Expressway is a new multi-lane limited access toll facility that will eventually connect I-95 in northern St. Johns County to I-10 in western Duval County. The northern section from Blanding Boulevard (SR 21) in Clay County to I-10 in Duval County is currently under construction and is scheduled for completion in 2017. Construction is also underway on the First Coast Expressway extension from I-10 to Beaver Street (US 90). Estimated completion for the extension section is Fall 2018.

### **Project Description**

The project limits for the southern section of the First Coast Expressway are from I-95 in St. Johns County to Blanding Blvd (SR 21) in Clay County. This section is currently in the preliminary design phase. Proposed improvements include:

- A multi-lane divided expressway from I-95 to Blanding Blvd.
- A new bridge over the St. Johns River south of the existing Shands Bridge.
- Drainage ponds.
- Automated tolling facilities for electronically paid tolls (SunPass). (More information on back).
