FDOT to Host Subsequent Public Hearing to Discuss Proposed Improvements to I-95 from I-10 to Beaver Street

JACKSONVILLE, Fla. – The Florida Department of Transportation (FDOT) will host a Subsequent Public Hearing next week to discuss proposed improvements to I-95 from I-10 to Beaver Street. The project is currently in the Design phase, and changes made to the project since the PD&E Public Hearing held in 2023 will be presented at this Subsequent Public Hearing.

Interested parties may participate in two ways:

- **Online:** A virtual public hearing will take place Monday, Dec. 2, with an open house from 5:30 to 6 p.m. followed by a formal presentation and public comment period at 6 p.m. Instructions for participation are available at www.nflroads.com/VPH.
- **In person:** An in-person public hearing will take place Tuesday, Dec. 3 at the FDOT Jacksonville Urban Office Training Center, 2198 Edison Avenue, Jacksonville, FL 32204. An open house will begin at 4:30 p.m., followed by a formal presentation and public comment period at 6 p.m.

All participants, regardless of the platform they choose, will receive the same information about the project. All comments received in-person, virtually, electronically, or by mail will be given equal consideration.

Persons wishing to submit written comments or questions may do so at the hearing or mail/email them to Michael Brock, P.E., 1109 S. Marion Ave., MS 2007, Lake City, FL 32025. Comments must be postmarked by Dec. 13, 2024, to be included in the public hearing record.

Public participation is solicited without regard to race, color, national origin, age, sex, religion, disability or family status.
