### **FDOT to Host Nov. 6 Public Meeting to Discuss Proposed Changes to Indigo Drive at Emerson Street**

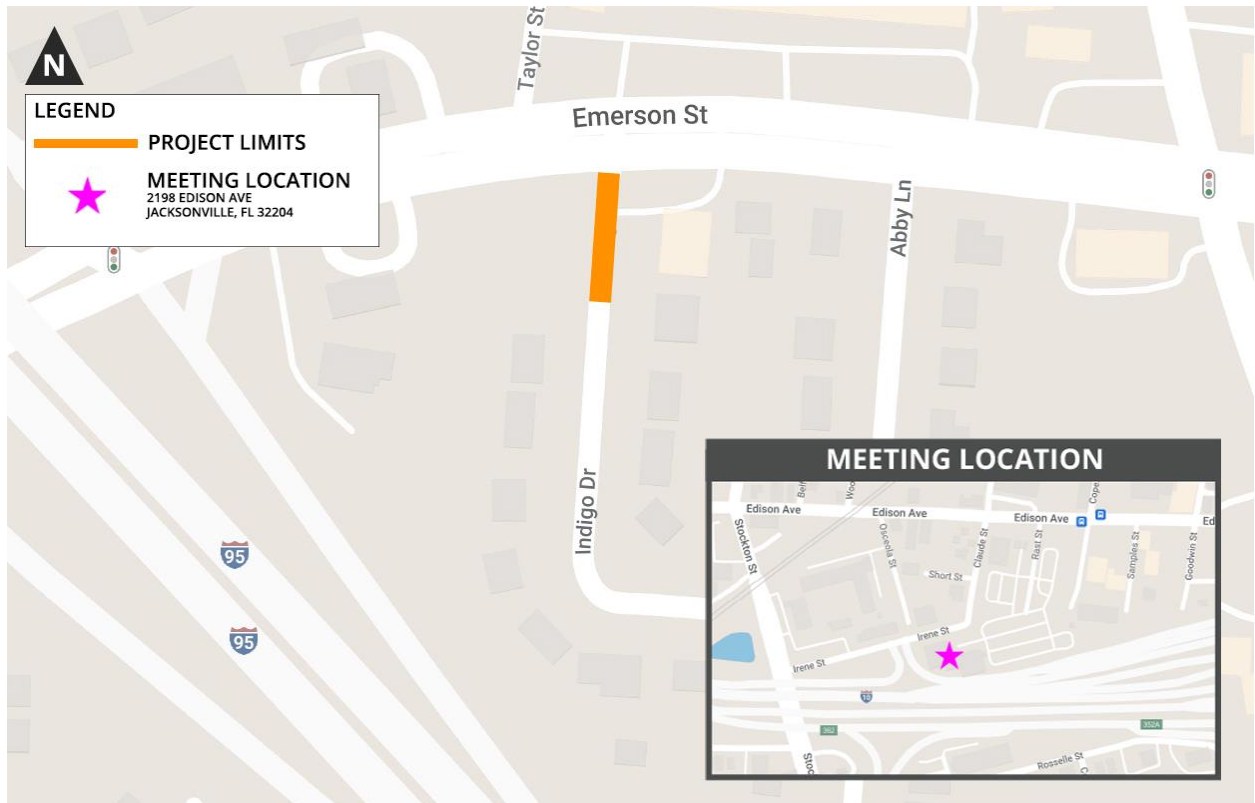
**JACKSONVILLE, Fla.** – The Florida Department of Transportation (FDOT) will hold a public meeting Monday, Nov. 6 from 5 to 6 p.m. to discuss proposed changes to Indigo Drive at Emerson Street as part of a project to widen I-95 from Atlantic Boulevard to south of Emerson Street (FIN 432259-2).

FDOT proposes installation of a cul-de-sac where Indigo Drive currently connects to Emerson Street. This change will mitigate a sight distance issue associated with the JEA lift station located at the southwest corner of the Emerson Street/Indigo Drive intersection. Construction of the cul-de-sac is expected to begin in 2024.

The meeting will take place virtually and in-person at the FDOT Jacksonville Urban Office, 2198 Edison Avenue, Jacksonville, FL 32204. Staff and consultants will be available from 5 to 6 p.m. to answer questions and accept comments. A formal presentation and public comment period will begin at 6 p.m. Project documents and virtual participation instructions are available at [nflroads.com/VPH](http://nflroads.com/VPH). Participants who are unable to attend the webinar virtually or in-person may listen to the meeting by calling (562) 247-8422 and entering access code 464-904-901.

Both virtual and in-person participants will be given equal opportunity to ask questions and make oral statements for the project record.
