

### I-10 at Cassat Avenue Ramps to be Detoured Overnight

**JACKSONVILLE, Fla.** – As part of FDOT’s project to widen I-10 from I-295 to I-95, overnight detours of the I-10 west to Cassat Avenue exit ramp and the Cassat Avenue to I-10 east on-ramp will be in place Wednesday, April 7 from 10 p.m. to 5 a.m., weather and unforeseen circumstances permitting.

**I-10 West to Cassat Avenue Exit Ramp Detour:** Drivers will be detoured at the Luna Street exit, turn right on Luna Street and turn left on Highway Avenue to connect with Cassat Avenue. (See map below.)



**Cassat Avenue to I-10 East On-Ramp:** Drivers on Cassat Avenue who wish to access I-10 east may take Highway Avenue or Lenox Avenue to Luna Street and take the Luna Street to I-10 east on-ramp. (See map below.)


