### **ICYMI: FDOT to Host Public Meetings Feb. 20 and 22 for Proposed State Road 16 Improvements**

**ICYMI: ST. JOHNS COUNTY, Fla.** – The Florida Department of Transportation (FDOT) will host two public meetings to discuss proposed State Road 16 improvements in St. Johns County. A Project Development and Environment (PD&E) study is currently underway to evaluate widening State Road 16 from International Golf Parkway to I-95 from the existing two-lane roadway to a four-lane divided roadway.

The meetings serve to inform the public of the proposed improvements and provide an opportunity for the public to express opinions and concerns regarding the project.
