

ICYMI: Multiple Detours Planned at J. Turner Butler Boulevard and San Pablo Road Interchange March 18 through March 21

JACKSONVILLE, Fla. – Multiple detours are planned at the J. Turner Butler Boulevard (JTB/State Road 202) and San Pablo Road interchange starting at 8 p.m. Friday, March 18 and continuing through 5 a.m. Monday, March 21, weather and unforeseen circumstances permitting. The closures are necessary to allow crews to transition traffic into a temporary diverging diamond interchange configuration.

Throughout the weekend, traffic on San Pablo Road will be unable to travel under the Butler Boulevard overpass. Depending on their direction of travel, drivers may be directed to make U-turns on San Pablo Road and take Butler Boulevard to Hodges Boulevard or Butler Boulevard to South Beach Parkway, allowing them to turn around and approach the interchange from the other direction, as shown in the map below.

Starting the morning of Monday, March 21, traffic at Butler Boulevard and San Pablo Road will be configured in a diverging diamond interchange. Drivers should pay attention to new signage, pavement markings and signals and use extra caution as they become accustomed to the new flow of traffic.
