Riverside Avenue from Goodwin Street to May Street closed overnight Tuesday and Wednesday

JACKSONVILLE, Fla. – Riverside Avenue from Goodwin Street to May Street is scheduled to close Tuesday, Nov. 3, and Wednesday, Nov. 4, from 9:30 p.m. to 6:30 a.m. the next morning for work related to the Riverside Avenue and Margaret Street intersection improvement project.

Northbound Riverside Avenue traffic will detour to Goodwin Street, Oak Street and Lomax Street to Riverside Avenue. Southbound Riverside Avenue traffic will detour to Margaret Street, Oak Street and Goodwin Street to Riverside Avenue.

Margaret Street will remain open for residential and business access. In addition, the Publix entrance on Riverside Avenue will be accessible.

FDOT's intersection and traffic signal improvement project at Riverside Avenue (State Road 211) and Margaret Street includes replacing overhead traffic signal span wires with two mast arm poles, upgrading pedestrian signals featuring countdown timers, installing new illuminated street signs, roadway striping and sidewalk and curb repairs. It is expected to be complete in early 2021, weather and unforeseen circumstances permitting.

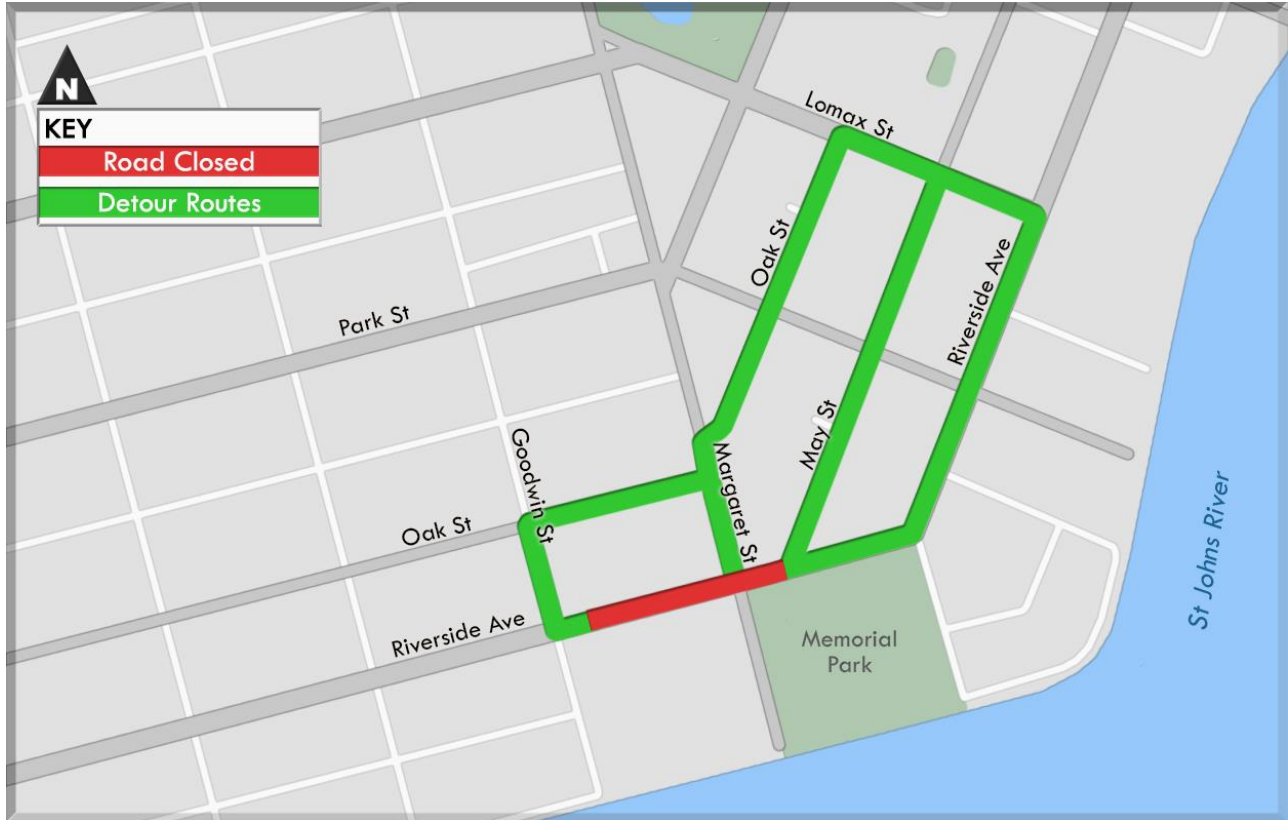
