Travel Advisory: State Road 200 Lane Closure Schedule

Yulee, Fla. – This advisory is to inform community leaders and interested parties about upcoming, scheduled lane closures, traffic shifts and other construction activity on State Road 200/A1A. For a complete list of scheduled lane closures in northeast Florida, interested parties may visit: www.NFLRoads.com/TrafficReport.

Drivers can also setup real-time traffic alerts from FL511, a free service offered by the Florida Department of Transportation (FDOT). Motorists can visit www.FL511.com or call #511 for this up-to-date information.

The Florida Department of Transportation has permitted multiple lane closures as part of the State Road 200/A1A (S.R. 200) improvement projects. Below are several planned lane closures, weather permitting, planned for August 23 through August 30. Certain activities may require unexpected lane closures for the safety of both drivers and construction workers.

Notable: A single lane closure will be in place on State Road 200/A1A eastbound beginning east of Semper Fi Drive and through the I-95 intersection on Tuesday, August 27 and Wednesday, August 28 from 7 p.m. to 6 a.m., weather and schedule permitting. The single lane closure will impact the I-95 off-ramp traffic flow.

Drivers attempting to exit I-95 southbound onto State Road 200/A1A eastbound will be detoured west to the first median crossover just west of Semper Fi Drive, where they can make a U-turn to join State Road 200/A1A eastbound. U-turns will not be permitted at Semper Fi Drive.

Drivers attempting to exit I-95 northbound onto State Road 200/A1A westbound will be detoured east to the median at Mentoria Road where they will be able to make a U-turn to join State Road 200/A1A westbound.

Daytime lane closures:

Interstate 95:

- The inside, southbound travel lane of Interstate 95 near exit 373 is expected to be closed from 9 a.m. until 3:30 p.m. Thursday, August 29. The interstate ramps will not be impacted.

State Road 200:

- The eastbound left lane of S.R. 200 will be closed from St. Peter Boulevard to Meadowfield Bluffs Road Saturday, August 24 from 7 a.m. until 5 p.m.
- The westbound left lane of S.R. 200 will be closed at the Lofton Creek Boat Ramp on Saturday, August 24 from 7 a.m. until 5 p.m.
- The westbound right lane of S.R. 200 from Gene Lasserre Boulevard to Peeples Road will be closed Saturday, August 24 from 7 a.m. until 5 p.m.
- The eastbound right lane of S.R. 200 from Arrigo Boulevard to Mt. Zion Loop will be closed Saturday, August 27 from 7 a.m. to 5 p.m.

Nighttime lane closures:**Interstate 95:**

- Southbound Interstate 95 lane closures are expected near exit 373 nightly, from 7 p.m. until 5:30 a.m. Wednesday, August 28 and Thursday, August 29. The work is associated with the Interstate median and Interstate inside shoulder. Note: this activity may require multi-lane closures on Interstate 95. The Interstate ramps will not be impacted.

State Road 200:

- The westbound right lane of S.R. 200 will be closed from David Hallman Parkway to Eric Oliver Way, Saturday, August 24 and Monday, August 26 from 9 p.m. to 6 a.m.
- The eastbound left turn lane of S.R. 200 onto Chester Road will be closed Saturday, August 24 from 9 p.m. until 6 a.m. and nightly Monday, August 26 through Friday, August 30 from 9 p.m. until 6 a.m.

Chester Road:

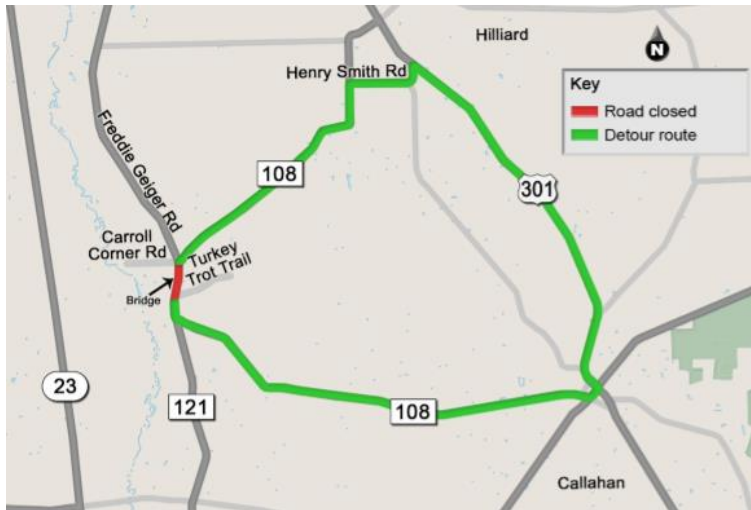
Note: These construction activities do not require a detour.

- The southbound right lane of Chester Road will be closed from David Hallman Parkway to State Road 200 on Saturday, August 24 from 9 p.m. to 6 a.m. and nightly Monday, August 26 through Thursday, August 29 from 9 p.m. to 6 a.m.
- The northbound lane of Chester Road from S.R. 200 to David Hallman Parkway will be closed Thursday, August 29 from 9 p.m. to 6 a.m.

Nassau County Advisory: While unrelated to the S.R. 200 corridor, interested parties may appreciate the following information:

The Florida Department of Transportation has temporarily closed a portion of County Road 121/Baldwin and Saint George Road between Turkey Trot Trail and Carroll Corner Road.

The closure will be in place until rehabilitation work is completed on a bridge culvert damaged from erosion. Northbound and southbound drivers on County Road 121 will detour to U.S. 301 via County Road 108 and Henry Smith Road.
