# Let's Talk Access Management



#### What is Access Management?

Access Management is the process used to plan the location, design, and operation of driveways, median openings, interchanges, and street connections. It promotes the efficient and safe movement of people and goods by reducing conflicts on the roadway system and at its interface with other modes of travel.

#### How does Access Management improve safety?

By reducing conflicts, Access Management reduces crashes.

#### Does Access Management keep customers away?


Access Management does not impact the demand on goods and services.

#### What positive impacts will good Access Management have on my business?

More efficient traffic flow and improved safety are two of the biggest benefits to Access Management.

One of the most important responsibilities of the Florida Department of Transportation (FDOT) is to ensure that the design of each state road properly balances access and mobility. Access management is used to provide this very important balance.

A basic principle of access management is to limit the number of conflict points along a roadway by minimizing the number of driveways and median openings and restricting certain movements at some median openings.







#### THE PROJECT DEVELOPMENT PROCESS

FDOT follows federal and state requirements throughout project development and works closely with governmental agencies, partners and local communities to identify new projects and move them through the production process.

The process includes Planning and
Feasibility, Project Development and
Environmental Study, Design, Right of Way
Acquisition, and Construction.



#### **Planning and Feasibility**

Determine the need for roadway improvements based on future lane uses and projected traffic volumes.

#### **Project Development and Environment Study**

The location and conceptual design of road improvements are identified and environmental and social impacts are assessed.

3

#### Design

Design plans are prepared.




#### **Right of Way Acquisition**

Additional land needed for improvements is purchased, if needed.



#### Construction

Build recommended improvements.



### DISTRICT TWO MODIFICATION PROPOSAL

## FDOT proposes the following modifications:

- Repurposing four through travel lanes into two through travel lanes on Edgewood Avenue South to install bicycle and shared use lanes throughout the project limits
- 2 Installing three new mid-block crossings with flashing beacons between Mayflower Street and Corby Street, Antisdale Street and Post Street and Post Street and Jasmine Place
- Relocating traffic signal heads due to lane repurposing
- Cleaning and re-coating the U.S. 17/Roosevelt Boulevard bridge
- **5** Connecting existing sidewalk with newly constructed sidewalk
- **6** Upgrading ADA curb ramps
- Upgrading existing pedestrian signals and installing new pedestrian signals
- **8** Completing minor utility improvements
