A formal hearing and public comment period will begin at 6:30 p.m. **Presentations, project-related material and the opportunity to speak, submit comments and questions will be the same whether participants attend online or in person.**

## ABOUT THE PROJECT

The Florida Department of Transportation (FDOT) proposes to close the median on U.S. 17/State Road 5/Main Street approximately 700 feet south of the current Broward River Bridge as part of the Broward River Bridge Replacement Project. This project also includes construction of a new bridge over the Broward River with a new median barrier wall and new sidewalk on the east side of the bridge. During construction, lane closures of the current bridge will be implemented in order to facilitate construction. The \$11.5 million project is expected to begin in summer 2021 with completion in late 2022, weather and unforeseen circumstances permitting.
