Study Request

The Florida Department of Transportation (FDOT) Traffic Operations Division received a request to evaluate the need for a mid-block crossing on the roadway segment of San Juan Avenue/SR 128 (Mile Post (MP) 0.200) between Lane Avenue and Jammes Road on October 27, 2017. The requestor, Lalaine F. Cate, states that residents from the Noble House Retirement Home like to cross to the commercial complex across the street. The existing crosswalks are too far away, as a result, pedestrians jaywalk, posing a safety concern to the area. This request can be found under Assignment Report Number 2017.0290 in the FDOT Traffic Operations' Tracker Database.

Existing Conditions

The location under evaluation, the study roadway segment (San Juan Avenue/SR 128), is located in Duval County. The straight-line diagram for this roadway, identified as 720170000, is provided in Appendix A.


A field review of the study area was conducted from 9:00 AM to 11:00 AM on December 21, 2017, encompassing the AM pedestrian peak hour. During this field review, pedestrians were seen jaywalking across the arterial.

San Juan Avenue/SR 128 is two-lane, undivided, urban minor arterials with 11-foot lanes and a 12-foot continuous left-turn lane with 2-foot shoulders. Signalized intersections with pedestrian crosswalks were found approximately 1,125 feet to the west and 1,215 feet to the east from the point of interest. The north side of San Juan Avenue/SR 128 consists mainly of residential areas including the retirement home and the south side consists mainly of commercial establishments with some residential housing. The speed limit through the area is posted as 40 mph per the field review dated December 2017. The Access Management Classification for this facility is a Class 6.

Figure 1 provides an existing conditions diagram for the intersection and photos of the study limits are provided in Appendix B.

Summary of Findings

According to FDOT Florida Traffic Online (2016), San Juan Avenue/SR 128 (Section Number 720170000) has an Annual Average Daily Traffic (AADT) of 16,100 vehicles per day (vpd). Due to the nature of this study, turning movement counts (TMC) as well as pedestrian/bicycle crossing counts were collected for three zones. The zones are shown in Figure 2. Zones A and C indicate the area for pedestrian/bicycle crossing counts and Zone B indicates the area where TMCs were obtained. Noble House Retirement Home is located in Zone B. The TMCs were collected during a three-day period, from December 5, 2017 to December 7, 2017. The pedestrian/bicycle crossing counts were one-day counts obtained on Tuesday, December 5, 2017.

Given the three-day counts for Zone B, it is important to note the variability between the three days is low. Therefore, it can be assumed that the pedestrian/bicycle counts from Zone A and Zone C are representative of a typical weekday.

According to FDOT's Traffic Engineering Manual (TEM) Section 3.8.5, a senior, disabled person, or a child should be counted twice when considering a midblock crossing. For the purposes of this study, half of the pedestrians crossing through Zone B were considered seniors and were counted twice. Although, the counts do not specify the classification, this assumption is considered reasonable and conservative due to the proximity of the retirement facility and field observations. The final assumption made was also in accordance with FDOT's TEM Section 3.8.5. Bicycles crossing the road may be counted as pedestrians and were considered so in Zone A and Zone C.

The TEM stipulates that a midblock crossing is warranted when one hour (a period of four consecutive 15-minute intervals) has a pedestrian volume of 20 or more crossing, two hours have pedestrian volumes of 18 or more, or three hours have pedestrian volumes of 15 or more. The summarized data in Table 1 shows the hours with 20 or more pedestrians per hour highlighted in red, the hours with 18 to 20 pedestrians per hour highlighted in orange, the hours with 15 to 18 pedestrians highlighted in yellow, and the pedestrian peak hours highlighted in gray. This data shows the need for a midblock crossing within the study area. The count data is provided in Appendix C.

The pedestrian demand requirements and the minimum location characteristic requirements set by the FDOT TEM Chapter 3, Section 8.5 are met by the study area limits along San Juan/SR 128. The minimum ADT requirement of 2,000 vpd is exceeded by San Juan Avenue/SR 128 with an AADT of 16,100 vpd. The distances to the nearest crossing locations are more than 1,000 feet to the east and west of the retirement facility, exceeding the spacing requirements between adjacent intersections of 660 feet. The proposed location for the midblock crossing is outside of the


influence area from the adjacent signalized intersections. Therefore, a midblock crossing can be considered at this location.

Crash data, available through SignalFour Analytics, was collected between January 1, 2012 and December 31, 2016. A summary of the crash severity is provided in Table 3. The study limits experienced 12 crashes within the time frame with the predominant crash types as rear-end collisions (42 percent), angle or sideswipe collisions (25 percent), off-road collisions (17 percent), and most importantly, pedestrian collisions (17 percent) as shown in Figure 3 (further explained below). All incidents occurred on dry surfaces and most during clear weather conditions (58 percent) with the remaining under cloudy weather conditions (42 percent). Most crashes occurred during daylight hours (75 percent), but three crashes documented dark, but lit conditions (25 percent). Careless driving was documented as the contributing factor in five crashes and improper lane change in one crash. A collision diagram is provided in Figure 3 and crash details are provided in Appendix D.

The first pedestrian-related collision occurred in 2013 during dusk lighting conditions. The weather was documented as clear, and the road surface as dry. The location of the incident was approximately 160 feet east of Noble House Retirement Home. A vehicle heading in the westbound direction, from a business parking lot on the south side of San Juan Ave/SR 128, struck two pedestrians. The two pedestrians involved in the collision were not utilizing a designated crosswalk as they crossed San Juan Avenue/SR 128, the nearest crosswalk to the crash location is approximately 980 feet to the east. The long-form crash report states that the driver was unable to see the pedestrians until entering the turn lane where the collision occurred. The long-form crash report also documented the age of the pedestrians as eight years of age and 43 years of age. Minor injuries were documented for both pedestrians, and neither were transported to the nearest hospital.


The second pedestrian-related collision occurred in 2014 at approximately noon. The weather conditions were documented as clear with dry road surface conditions. The location of the incident was approximately 315 feet west of Noble House Retirement Home. A vehicle traveling in an unknown direction along San Juan Avenue/SR 128 struck a pedestrian. The pedestrian was not utilizing a designated crosswalk. The nearest crosswalk is approximately 770 feet west from the collision location. The long-form crash report states the driver fled the scene of the crash. The long-form also documents injuries for the pedestrian.

Additionally, criteria provided in the Manual on Uniform Traffic Studies (MUTS) for signal warrants was evaluated to determine if a signal was necessary at this intersection. Warrant 4 evaluates the necessity of a traffic signal due to pedestrian traffic volume. The major street traffic volumes and the pedestrian volumes fall below the critical curve as shown in Appendix E. Thus, a traffic signal is not warranted at this intersection.

Recommendations and Conclusions

The San Juan Avenue/SR 128 roadway has high pedestrian volumes within the study limit. Most of the pedestrians were observed jaywalking due to the lack of nearby crosswalk and that poses the safety concerns near the study area. Based on existing site conditions, the recent five-year crash data summary, and evaluation criteria set forth by FDOT's TEM and the MUTS for midblock crossing justification and signal warrants, the installation of a midblock crosswalk, and pedestrian warning signs across San Juan Avenue/SR 128 are recommended.

A Rectangular Rapid Flashing Beacon (RRFB) is recommended for installation outside both the eastbound and westbound outside travel lanes. Furthermore, it is recommended that the RRFBs at both locations be double-sided, so drivers traveling in both the eastbound and westbound directions can see the indication. The recommendations of the midblock crossing and the RRFBs are shown in Figure 4.







Figure 4C-5. Criteria for "100%" Volume Level





Figure 4C-7. Criteria for "100%" Volume Level - Peak Hour


