



MARCH 10, 2022

- The proposed improvements include the construction of new sections of median and turn lanes from 12th Street to Winona Drive along Main Street (State Road 5).
- To accommodate the proposed 5-lane typical section and to comply with current design standards, 25 of the 40 existing on-street parking spaces will be removed.
- These proposed changes will enhance traffic flow, improve safety, and reduce rear-end collisions.
