




# SR-5A (King Street) Bridge Replacement over the San Sebastian River

Financial Management ID: 437428-1-52-01

Please join the FDOT to discuss Bridge Replacement plans being proposed for SR 5A (King Street) over the San Sebastian River.

- The bridge replacement project is currently in the design phase and is scheduled to go to construction in summer 2024.
- The proposed bridge will include two 11 ft. travel lanes, One 11 ft. turn lane, 10 ft. sidewalk on the northside of bridge and a 6 ft. sidewalk on the southside of the bridge.
- Upgraded aesthetic lighting and bridge rail will also be installed as part of this project.
- A detour will be necessary for the duration of the project while crews complete demolition work and build the replacement bridge.
