

PROJECT HISTORY

The Florida Department of Transportation (FDOT) conducted a Project Development & Environment (PD&E) Study to evaluate alternatives to improve safety, capacity, and traffic operations on I-95 from I-10 to Beaver Street. In January and February 2023. FDOT conducted a virtual and inperson public hearing to obtain public input on the recommended alternative. Since that time. changes have been made to the project. Stakeholders are invited to a subsequent public hearing to review these changes and provide comments regarding these proposed improvements.

The proposed project will rehabilitate and replace the deck of the Myrtle Avenue Bridge (Bridge No. 720163) as well as add up to two 12-foot travel lanes in each direction on I-95. Access management changes are also proposed and are summarized on the back of this flyer.



PROPOSED RIGHT-OF-WAY



PROPOSED DESIGN CHANGES

Based on input gathered at the prior public hearing, the following concerns have been addressed in the updated proposed build alternative concept:

- ACCESS CHANGE
- OTHER DESIGN CHANGE

- The Margaret Street roundabout is no longer proposed. In addition, the access ramp from Forest Street to I-95 northbound has been relocated to accommodate traffic from South Myrtle Avenue.
- The Church Street entrance to I-95 southbound that would have conflicted with the Emerald Trail as shown in the 2023 Concept is no longer proposed.



ACCESS MANAGEMENT

Access Management is the careful planning of the location, design and type of access to properties, businesses and homes. This also includes driveways and median opening guidelines. Access Management serves to promote safe and efficient movement of people and goods by reducing conflict. FDOT is recommending the following access management changes since the 2023 public hearing:

- Access modifications along Park Street from I-95 to Edison Avenue are no longer proposed. The current concept consists of re-striping Park Street between Edison Avenue and Forest Street to provide dual left turn bays from Park Street to Forest Street.
- The roundabout at Beaver Street that was part of the 2023 concept is no longer proposed. As a result, there will be fewer I-95 access ramps from Church Street, Beaver Street, and Union Street as compared to the 2023 concept.
