

The Florida Department of Transportation (FDOT) District Two welcomes you to the Hybrid Public Meeting for the SR 24 (Waldo Road) Resurfacing Project to discuss the proposed improvements to SR 24 (Waldo Road) from west of NE 141st Drive to US 301 in Alachua County, Florida. This meeting informs the public of the proposed improvements and serves as an official forum providing an opportunity for the public to express their opinions and concerns regarding the project.

Previously, a virtual and in-person public meeting were held on July 18, 2023 and July 20, 2023, respectively, to present improvements, including repurposing the existing two-lane SR 24 (Waldo Road) to a one-lane, one-way road with a buffered bicycle lane and on-street parking. Based on public feedback, the lane repurposing improvements have been eliminated, and the typical section will remain as a two-lane, one-way road with on-street parking.




PROJECT LOCATION MAP





PROJECT DEVELOPMENT PHASES
