

D.R. Horton has requested a permit to develop the Bridle Creek Subdivision for residential use.

To maintain safety and manage access to the proposed site, FDOT would require the developer to construct a directional median on Normandy Boulevard, east of Manning Cemetery Road. The developer would fund this construction at no cost to taxpayers.
