

The purpose of this public meeting is to give interested persons an opportunity to express their views concerning the location, conceptual design, and potential social, economic, and environmental effects of the proposed improvements.

A Project Development & Environment (PD&E) Study is being conducted by FDOT to evaluate alternatives to improve the safety and operational performance of the Stockton Street interchange at I-10.

This project proposes to relocate the existing westbound I-10 on and off ramps to the east to extend the distance for vehicles merging onto I-10 westbound and to improve the on and off ramps geometries.
