About the Project

This Access Management Project is being conducted to improve intersection operations, safety and pedestrian facilities. FDOT is proposing to reconfigure the intersection of Park Street at Blanding Boulevard (SR 21) from a signalized intersection into a roundabout, with the addition of pedestrian facilities along Park Street, as shown on the map below.



What is Access Management?

Access management is the careful planning of the location, design and type of access to properties, businesses and homes. This also includes median openings and driveway opening guidelines. Access management serves to promote safe and efficient movement of people and goods by reducing traffic conflict.

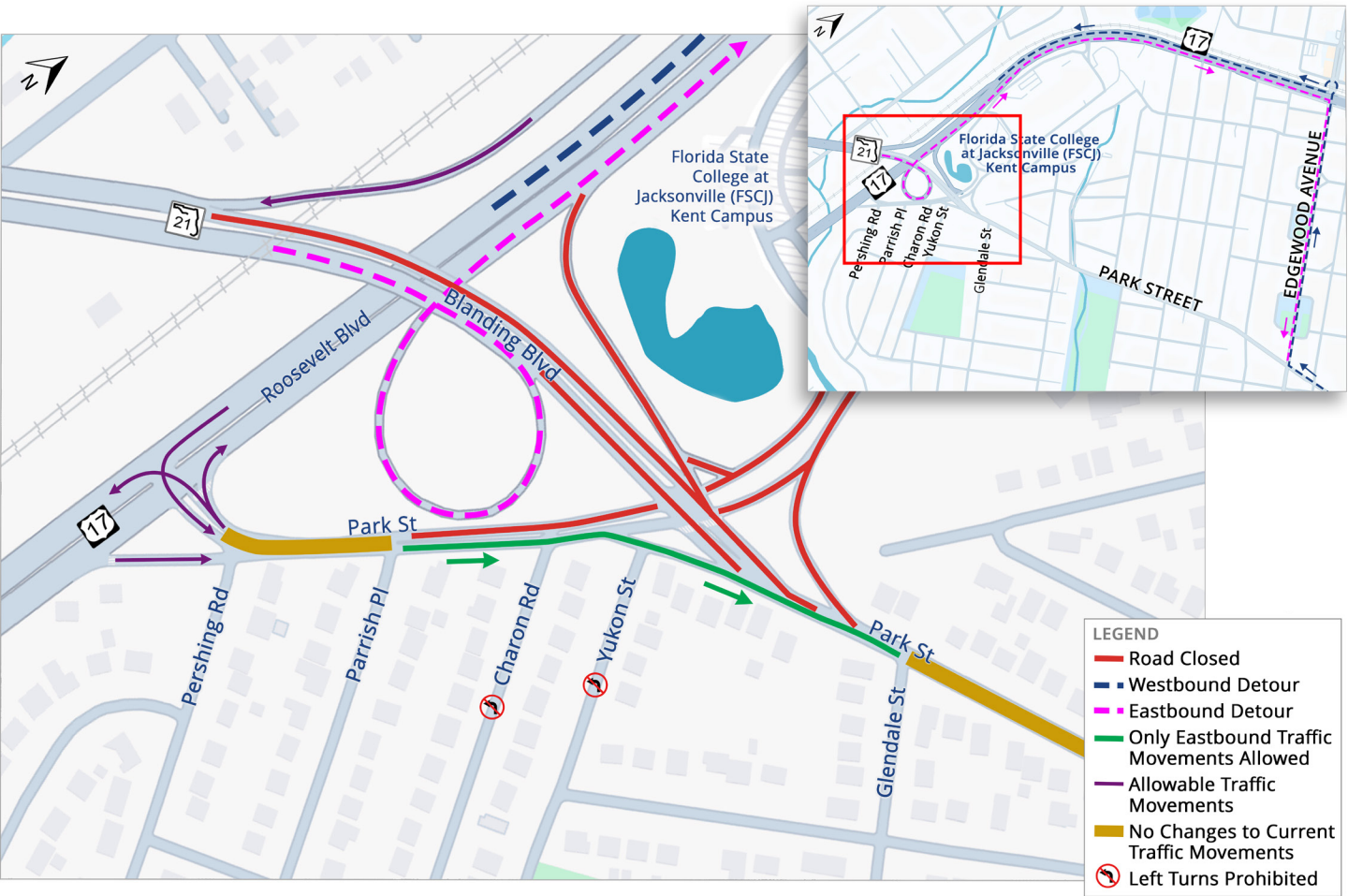

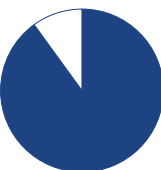
Project Detour

The intersection of Park Street at State Road 21, or Blanding Boulevard, and the south entrance to Florida State College at Jacksonville (FSCJ) Kent Campus will be closed from mid-May 2027 to the end of July 2027 to facilitate construction activities. Traffic will be detoured around the intersection closure utilizing Edgewood Avenue and US 17, as shown on the map below.

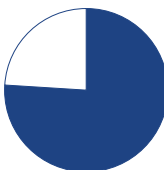
