





District Two of the Florida Department of Transportation invites you to attend a public meeting to discuss a proposed median modification on Crill Avenue (State Road 20) at Florida Drive, in Putnam County.

The project includes resurfacing, restoration and rehabilitation along State Road 20 (Crill Avenue) from Rowland Avenue to South Palm Avenue. Work will include milling and resurfacing the roadway. As part of the project, FDOT proposes modifications to the median opening on Crill Avenue (State Road 20) at Florida Drive, eliminating eastbound left turns to improve safety near the signalized intersection at State Road 19.


